The Regal Investment Fund ("RF1") Net Asset Value ("NAV") increased by 2.1% to \$3.52 in October. Since inception on 17 June 2019, the Fund has generated 19.6% p.a. net of fees.¹

Global equity markets were mildly lower in October, the S&P500 declining -1.0%, the tech-heavy NASDAQ Composite falling -0.5% and MSCI World retreating -0.5% as investors navigated increasing conflict in the Middle East and the potential outcomes of the upcoming November US presidential elections. Gold rose to another record high of the year, reaching USD\$2,750/oz, while crude oil fell to US\$70.22/bbl despite the increasing tensions in the Middle East. In Australian equities, the ASX Small Ordinaries Index gained 0.8%, again outperforming the ASX200, which declined -1.3%. Materials underperformed through the month as markets continued to digest the ramifications of last month's Chinese stimulus measures. Mainland Chinese equities gave back some of their recent gains (SHCOMP -1.7%) the AUD declined to 65.80usc.

Six of the eight strategies delivered positive returns for October, led predominately by the Market Neutral strategy. Within the Market Neutral strategy, long positions in buy-now-pay-later providers ZipCo (+10%) and Block Inc (+16%) contributed positively, following increasing evidence of growing transaction volumes across the US market, alongside short positions in discretionary retail, information technology and businesses facing the homebuilding sector.

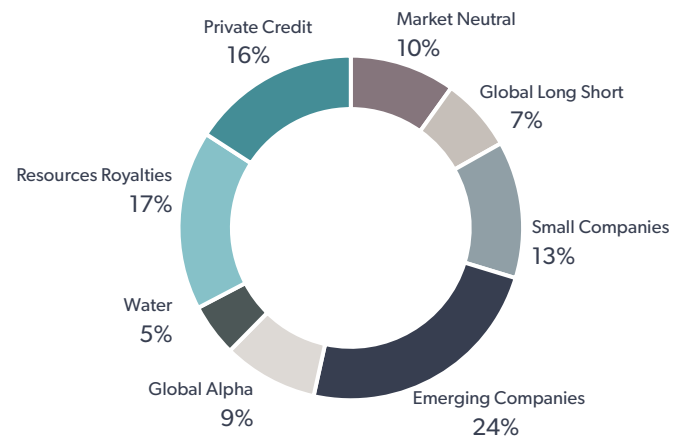
Negative performance within the Global Alpha strategy was the main detractor this month as a number of short positions suffered large squeezes.

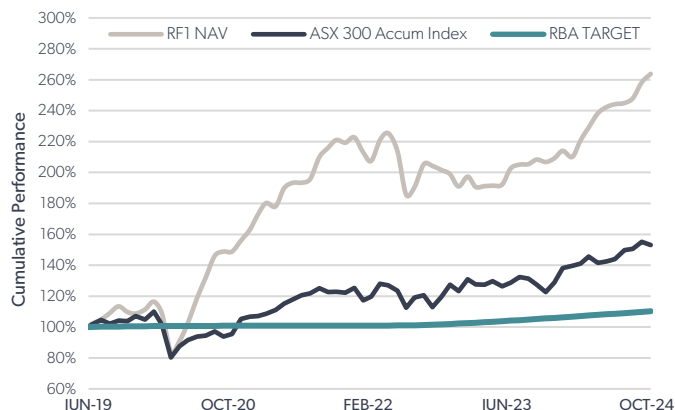

The investment objective of RF1 is to provide investors with exposure to a selection of alternative investment strategies with the aim of producing attractive risk-adjusted absolute returns over a period of more than five years with limited correlation to equity markets. Regal Funds Management Pty Limited's ("Regal" or the "Manager") investment philosophy is grounded in the belief that a diversified portfolio of assets, using a range of investment strategies and backed by long-term capital, is key to achieving superior risk-adjusted returns over the long-term.

The RF1 portfolio is constructed by the Manager using multiple investment strategies managed by it. The Manager may adjust the portfolio's strategy allocations depending on prevailing market conditions or other factors it considers relevant at the time in order to achieve RF1's investment objectives.
